Conduct Chart (9-12)

The following conduct code indicates the types of disciplinary action that may apply to each offense. These actions may be applied to a first time or repeated incident. Progressive consequences, when applicable, are listed for each subsequent offense within the respective education code violation.

Administrators use this code as a guide intended to standardize disciplinary procedures throughout the District. The recommendations are not intended to substitute for the judgment of professional personnel based upon knowledge of the student's behavior record and statutory restraints.

Pursuant to California Education Code section 48900.5 a student may be suspended on the first offense if it is determined that the student violated E.C. 48900 (a-e) or that pupil's presence causes a danger to persons. Count only full day(s) of suspension, partial days (e.g., incident or return date are not recorded as suspension dates.)
